Program Conditions:

- ¹ For non-heating doors and commercial customers that use natural gas for space heating.
- ² Limit one per address.
- ³ (Excludes Schools) New Non Atmospheric hydronic boiler, thermal efficiency from 85% to 88% & must replace an atmospheric boiler operating in a continuous loop. Rental boilers are eligible. Boilers under 300 MBH must have an AFUE of 85% or greater, limit one per address. Boilers up to 1,500 MBH can be used for water heating as well.
- ⁴ Space Heating only, non-atmospheric hydronic only, combustion efficiency of 83% or higher. Must replace existing boiler(s) equipped with a draft hood or a barometric vent.
- ⁵ To be used for space conditioning (not process heating) applications only. Product must have a minimum air flow capacity of 300 CFM per unit. Not to be used to recover energy from airstreams containing noxious or toxic fumes. Not to be used as part of a restaurant exhaust system. Frost control must be used for an ERV where winter design temperature is below 0 degrees F. Offer is valid only if the technology is used for common areas. Each unit must have a minimum Heat Recovery Effectiveness of 61% for an HRV and 67% for an ERV. For installations that have an electric humidification, the HRV rather than ERV incentive would apply.
- ⁶ For Hotel/Motel, Hospitals, Healthcare, Nursing Homes and Commercial Laundry facilities only processing a minimum of 100,000 lbs of laundry/year.
